

Environmental management statement

1. Purpose

This Environmental Management Statement aims to clarify Shanshan Technology's purpose, principles, and objectives in environmental protection, showcasing the company's commitment and actions in environmental management. Through this statement, we will provide guidance for Shanshan Technology's global environmental management, promote green and sustainable development, integrate sustainable development concepts into production, operations, and daily activities, reduce environmental impact, and offer stakeholders a clear environmental management framework and information. Shanshan Technology encourages business partners (customers, suppliers, etc.) and internal employees to jointly comply with the provisions of this document.

2. Scope of Application

This statement applies to all business activities and management behaviors of Shanghai New Materials Co., Ltd. and/or its global subsidiaries and affiliates (collectively referred to as "Shanshan Technology") worldwide, including but not limited to issues such as energy consumption, greenhouse gas emissions, water resource management, biodiversity conservation, air pollution control, raw material and chemical management, waste management, product use stages, and environmental impacts at the end of product life.

3. Management Structure

The company has established a Safety Production Committee (referred to as the "Safety Committee"), composed of senior group leaders, heads of business departments, and some employees. As the highest decision-making body in environmental management, the Safety Committee is responsible for formulating environmental management strategies, supervising the implementation of relevant environmental policies and targets, regularly evaluating environmental management performance, and organizing each production site to carry out environmental factor identification, compliance reviews, internal audits, and management reviews, ensuring efficient advancement and transparency of environmental management work.

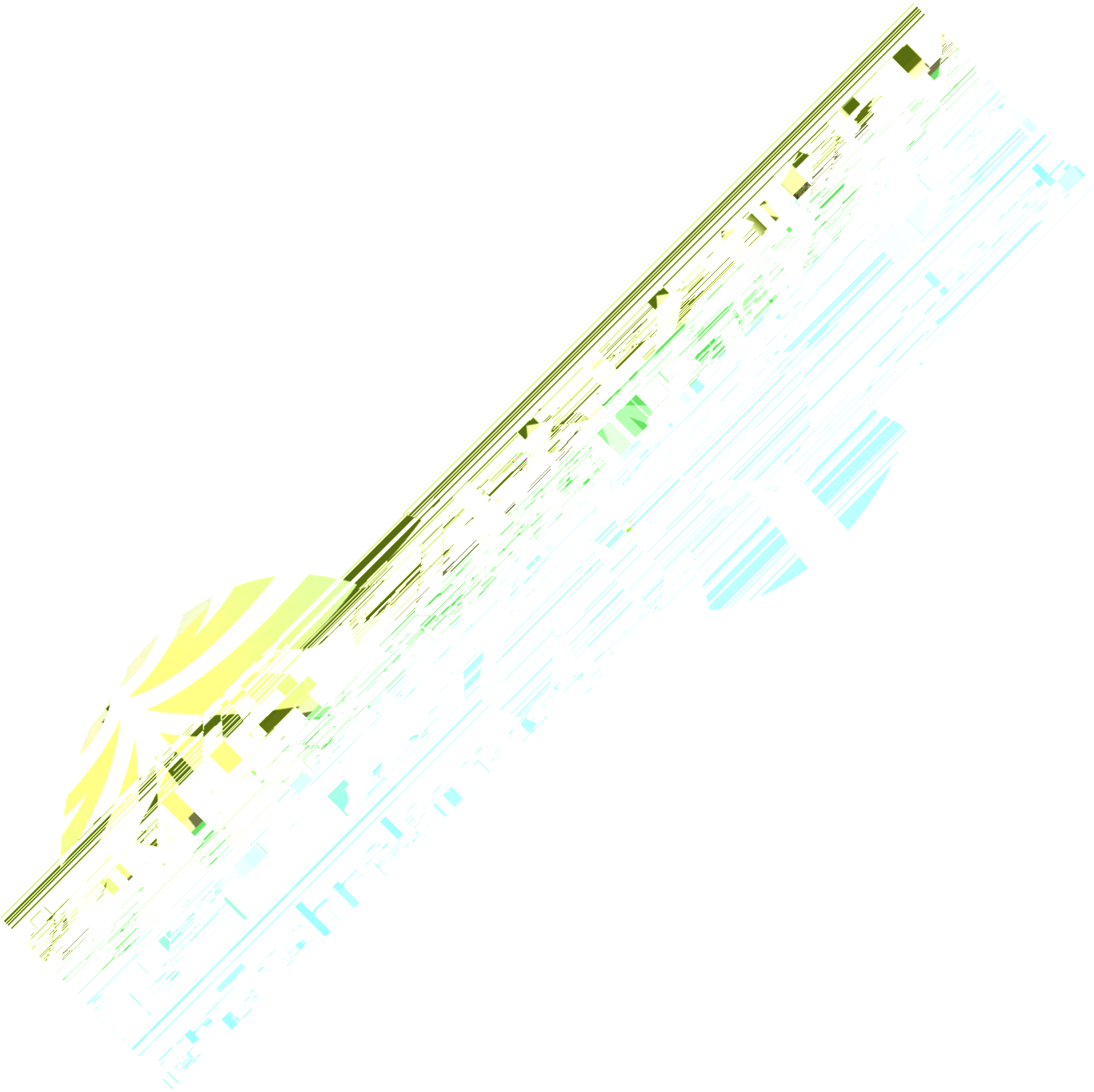

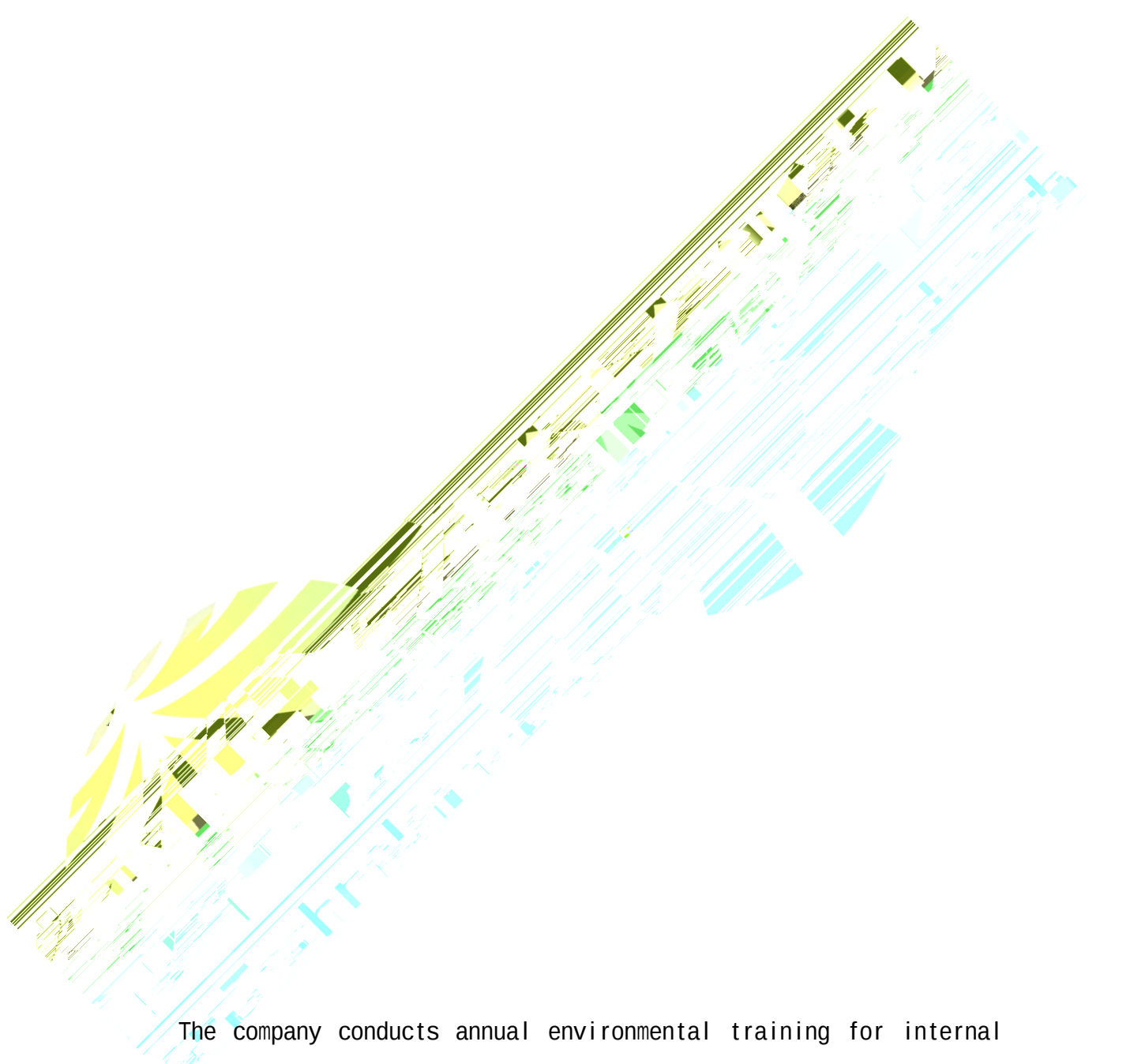
The company actively responds to the national "carbon peaking and carbon neutrality" strategy and implements its management responsibilities to address climate change. Each year, the company's greenhouse gas emissions are reviewed by third-party organizations and continuously updated and disclosed through appropriate channels.
